

# ***Bangladesh Development Research Working Paper Series (BDRWPS)***

## **Information for Contributors**

The *Bangladesh Development Research Working Paper Series (BDRWPS)* publishes policy-oriented non-technical papers on Bangladesh development issues. The main purpose of the *BDRWPS* is to disseminate findings of work in progress, to encourage the exchange of ideas about development issues of Bangladesh, and to enhance the process of knowledge generation. The *BDRWPS* aims at sharing such findings and ideas without requiring them to be fully polished, though manuscripts need to be spell-checked and references need to be complete and error-free (please see below for further details). Authors are encouraged to use the feedback resulting from the publication within the *BDRWPS* to revise their work and to submit it subsequently for more formal publication. Copyrights of the contents of the work submitted remain with the author(s) and/or the institution(s) submitting the work. The BDRC provides no paper copies, though paper copies can be downloaded freely from the BDRC's website.

### **I. Submission of manuscripts**

The invitation to submit manuscripts for publication in the *BDRWPS* is offered to all professionals as long as the topic is relevant to Bangladesh's development and the manuscript's quality measures up to the standard of the *BDRWPS*. Manuscripts, which are deemed suitable, will be peer-reviewed, whereby peers normally make their decision within one month after the receipt of the manuscript. Manuscripts need to be submitted electronically to Dr. Bernhard Gunter ([president@bangladeshstudies.org](mailto:president@bangladeshstudies.org)), whereby manuscripts should be single-spaced throughout and be within the range of 7 000 to 10 000 words (including footnotes and references). Manuscripts of more than 10 000 words will not be considered. There are neither submission fees nor page charges.

### **II. General preparation of manuscripts**

The first page of the manuscript needs to include (a) the paper's title, (b) the author's name, title, current address, telephone, and e-mail address, and (c) an abstract of 150 to 200 words, and a word count. Papers must be submitted in English. No more than three levels of headings should be used. Footnotes should be used in limited numbers and need to be placed at the bottom of the page. Quotes should be in quotations marks and if longer than 25 words indented, and referenced including the page number of the source. Manuscripts need to be provided as MS<sup>®</sup> Word documents. Simple tables can be in MS<sup>®</sup> Word, extensive tables should be provided as separate MS<sup>®</sup> Excel files.

### **III. Style of references**

The reference style needs to follow the following examples:

**c) References to monographs/books:** Taylor, Lance (2004) *Reconstructing Macroeconomics*, Cambridge: Harvard University Press.

**d) References to unpublished items:** Rodrik, Dani (2004) "Rethinking Growth Policies in the Developing World", Draft of the Luca d'Agliano Lecture delivered in Torino, Italy (October 8).
